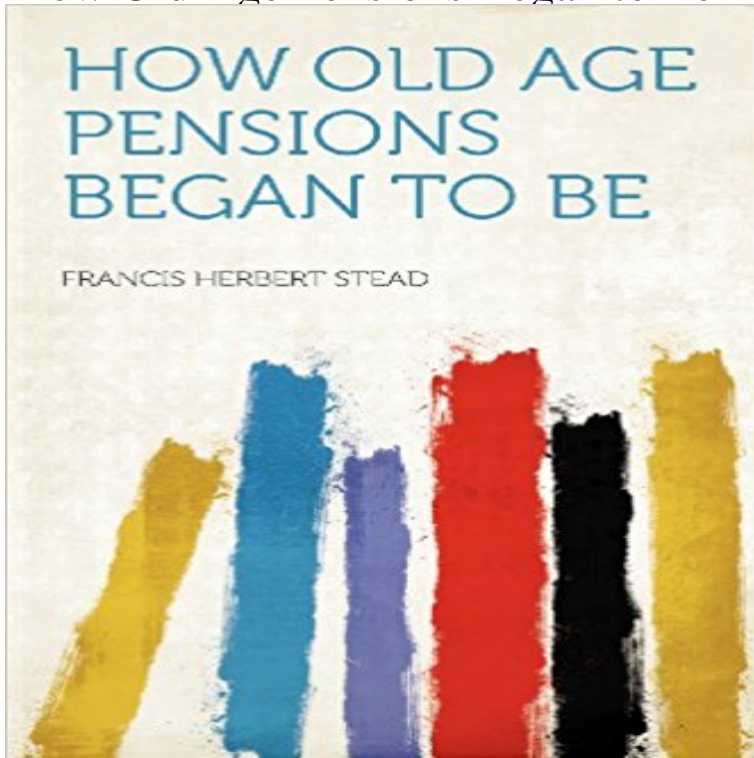


## How Old Age Pensions Began to Be
