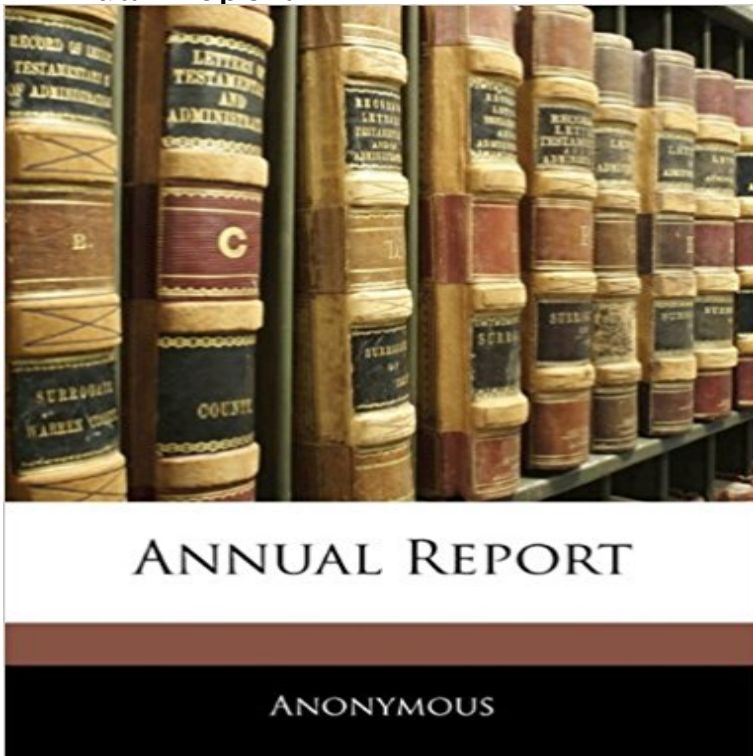


# Annual Report
