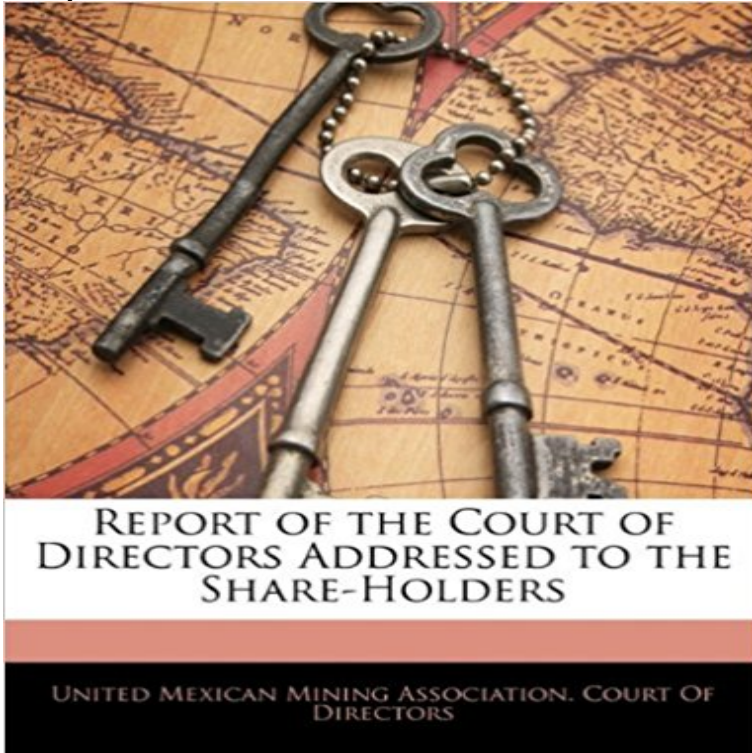


## Report of the Court of Directors Addressed to the Share-Holders

Whenever the board submits a proposal to shareholders for a vote, the board financial statements, internal management reports and shareholder lists.
