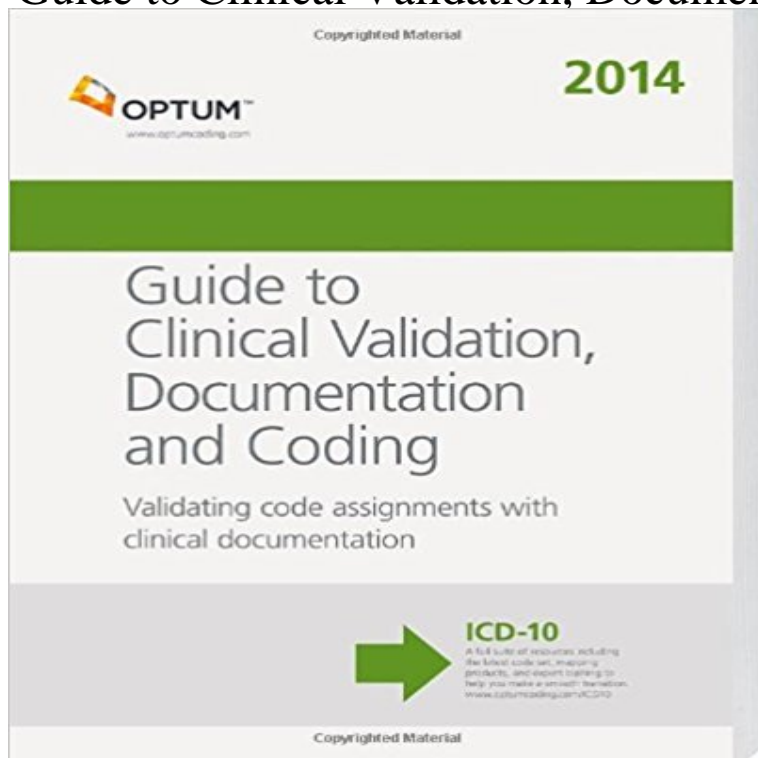


Guide to Clinical Validation, Documentation and Coding 2014
