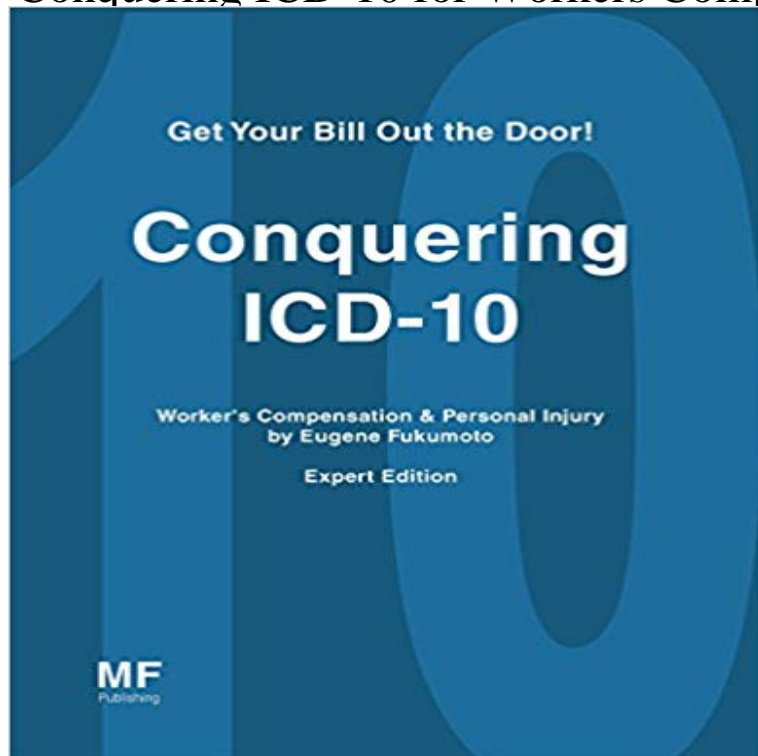


## Conquering ICD-10 for Workers Compensation and Personal Injury
