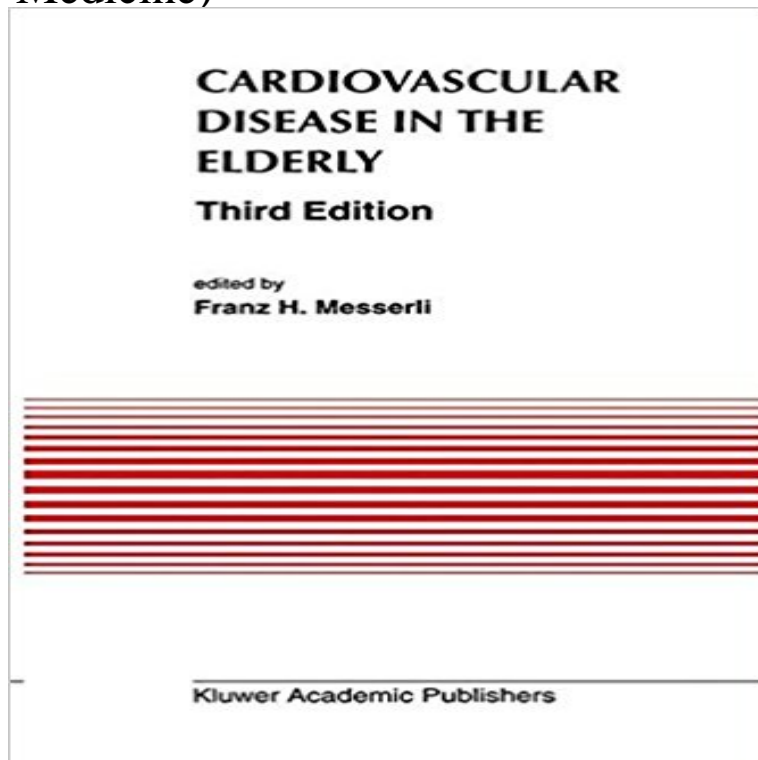


# Cardiovascular Disease in the Elderly (Developments in Cardiovascular Medicine)
