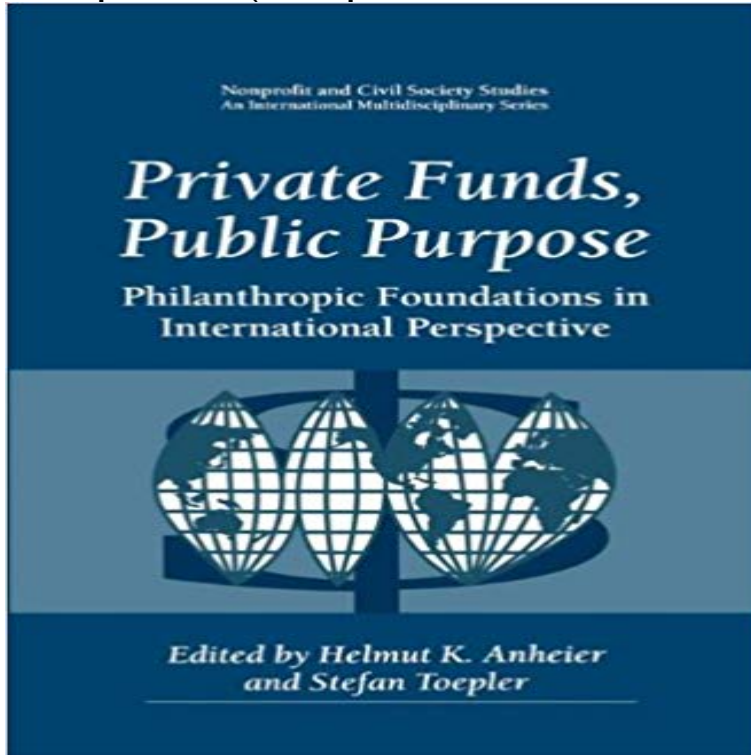


# Private Funds, Public Purpose: Philanthropic Foundations in International Perspective (Nonprofit and Civil Society Studies)



Comparative information detailing the cultural, legal and historical environments of foundations in international settings has been scarce - until now. Written by scholars from six countries, this text covers philanthropic foundations in the worlds busiest commercial centers - the U.S. and Eastern and Western Europe. It reports on the structures and mindsets that shape foundations gift giving, and discusses different aspects of foundation management. Case studies of the French and Italian foundation communities and a comparative legal chapter are especially notable.
