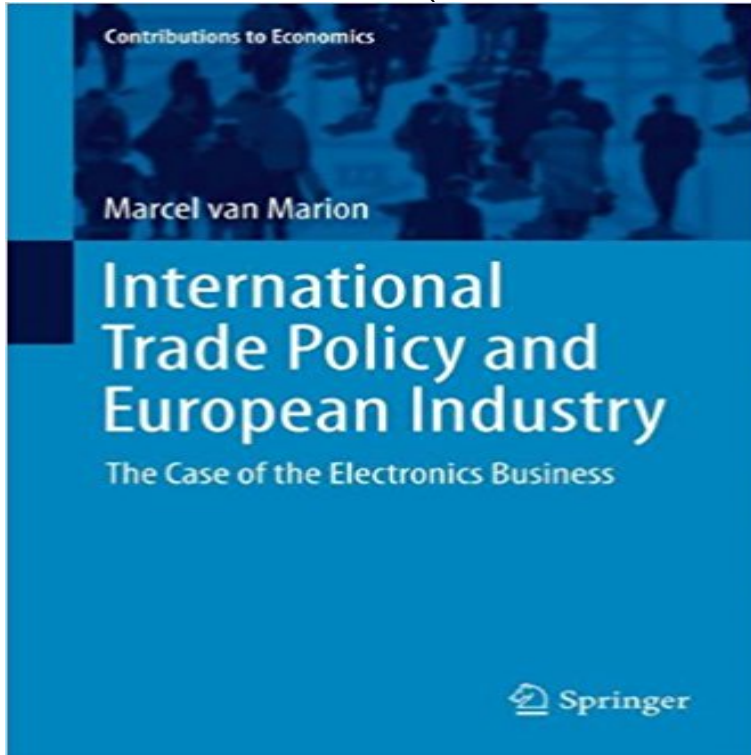


International Trade Policy and European Industry: The Case of the Electronics Business (Contributions to Economics)
