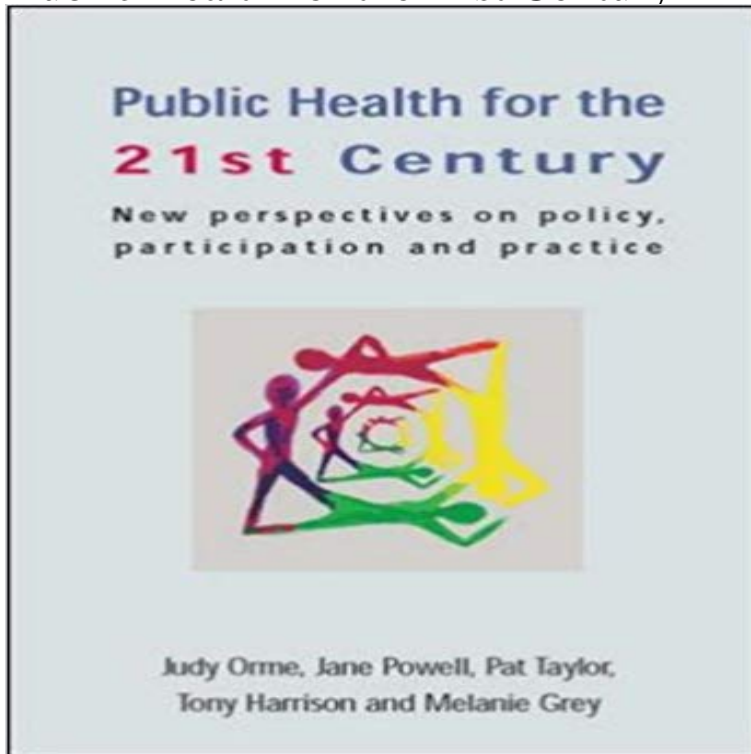


## Public Health for the 21st Century
