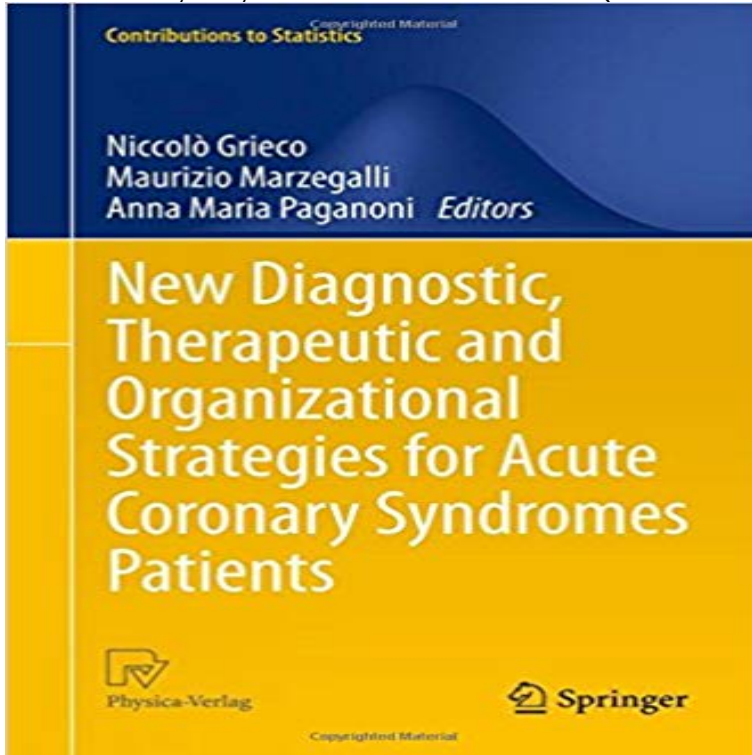


New Diagnostic, Therapeutic and Organizational Strategies for Acute Coronary Syndromes Patients (Contributions to Statistics)
