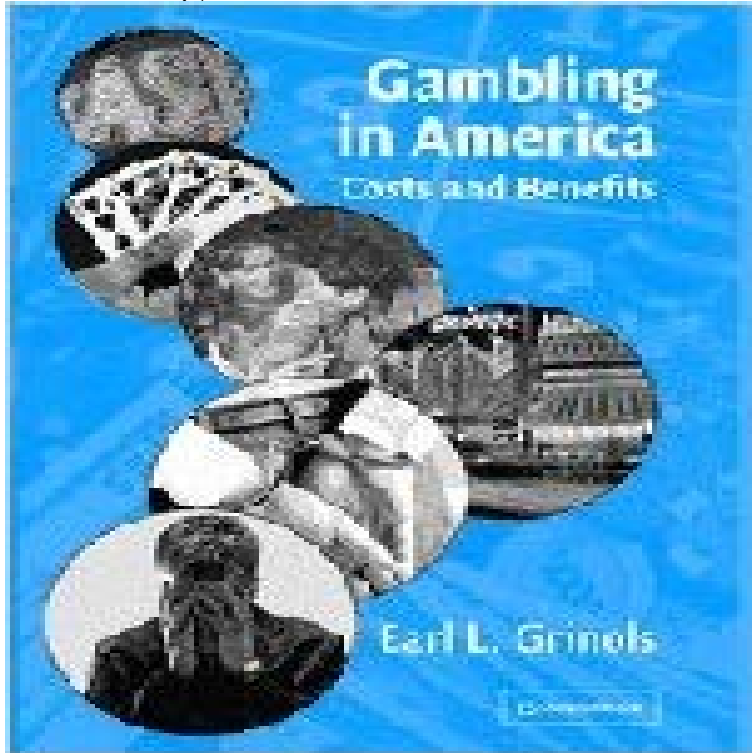


Gambling in America: Costs and Benefits
